

# TWO MEN STAR IN THE MEET

Robinson and Goeltz of Keewatin  
Academy Sensations of the  
Interscholastic.

FORMER DOES SPRINTS  
IN RECORD TIME

Robinson Qualifies in Seven Events  
and Stars in All of  
Them.

Running the 220 in 21 3-5 seconds and the 100 in ten seconds flat, Robinson of Keewatin academy shared the individual honors of yesterday's preliminary trials in the Michigan interscholastic with his team mate, Goeltz, who took both his heats in the low and high hurdles, won the shot put trial, and qualified in the high jump, broad jump and discus.

As a result of the preliminary trials, Keewatin academy, Lewis Institute and Grand Rapids Central all have 11 men qualified for the final events today, with Chicago University high running in fourth place with ten qualified.

Shadford of Ann Arbor high ran third in the second heat of the 880-yard run and was the only member of the local school team to qualify for today's contests. Shadford was far behind when the bunch hit the stretch but he pulled a beautiful finish and nosed his way into third place.

Judging from the showing made yesterday, Keewatin will win the meet unless Robinson is disqualified. He ran under protest yesterday, as charges were made that he was over 21 years of age. According to all information that can be secured, the speedy Keewatin man was 21 years of age last month, but he certainly looks to be quite some older than that. University high will probably cop second place with Lewis Institute and Grand Rapids Central fighting it out for third.
