

DECKERVILLE HI SHADES SANDUSKY, 49-48, TO WIN SANILAC TRACK HONORS

Deckerville, June 4.—By virtue of their girls' track team, Deckerville High school nosed out Sandusky by a one point margin in the annual Sanilac county High school field meet here Saturday afternoon.

Combined points for both boys and girls were: Deckerville, 49; Sandusky, 48; Croswell, 22; Brown City, 21; Marlette, 10; Peck, 4.

An odd feature of the meet was that Sandusky, which did not enter a girl's team annexed 48 points in the boy's meet to Deckerville's 28. Deckerville girls however, amassed nearly as many points as the boys to win the meet. The Deckerville girls made 21 points in four girl's events.

Sandusky boys won the boy's meet trophy and Deckerville girls won the girl's trophy. Deckerville also won the combined trophy as high for the meet.

No county records were broken in the track and field events.
