Algonac, Bloomfield Keep Their Titles in Classes C, D

 EAST LANSING, May 27.—Two repeat champions and a pair of new titlists emerged at the head of the battling here today in the thirty-third annual state interscholastic track and field meet on the Michigan State College track.

Successful in the retention of their 1938 laurels were Algonac in Class C, and Bloomfield Hills in Class D. Meantime, River Rouge came off with its first Class A title, while St. Joseph topped the proceedings in Class B.

The victory of River Rouge marks the return of the "A" pennant to the Metropolitan Detroit area for the first time since 1930. In that year, the last time Detroit schools vied in State competition, Northwestern annexed the championship.

Saginaw Far Back

In winning today, the Panthers garnered 34½ points to outclass the rest of the field. Lansing Central wound up second with 26, as Saginaw, the defending champion, lagged far behind with 8½.

River Rouge produced only two individual champions, Paul White in the high hurdles and Otis Wade in the high jump. Lowell Healey of the Panthers broke into the scoring column in three events by placing third in the broad jump, fourth in the 220-yard dash and fifth in the Century.

Besides his first, White also gained two points with a fifth in the low hurdles. Johnny Moehl took a second in the same event.

Pulls Hat Trick

Gordon Craig, a junior, pulled the "hat" trick to pace Bloomfield Hills to a decisive triumph in Class D with 42 points. He captured the 100-yard dash, the low hurdles and the broad jump and then finished his day's effort by running the anchor leg on Bloomfield's winning relay team.

Young Craig was easily the outstanding performer among the field of more than 700 who contested today. Ronald Mead of East Lansing in Class B is deserving of second place mention, although two entries cracked State entries. Stocky-built Mead ran his string of victories to six straight in State competition by retaining his 100 and 220-yard dash titles. The stiff wind which forced officials to disallow all running records today deprived Mead of getting his name placed on the books with a 9.8 "100."

Phils Downed By Giants 10-1

PHILADELPHIA, May 27.—Hal Schumacher today hung up his third victory of the season as the New York Giants drummed out 14 hits off four Philly pitchers and triumphed, 10 to 1.

Zeke Bonura led the Giant assault, counting a home run among his four hits. The veteran Tony Lazzeri played third for the New Yorkers, made one hit and scored twice.
