SUMMARY OF MEET REGULATIONS

1. The Girls 300 M Low Hurdles replaces the 200 M Low Hurdles in the order of events.

2. The Boys race in an event is to be run first in all co-ed Regionals and Finals.

3. Relay teams (Rule 5-9-2) - Each school is required to enter its relay teams (advise the Manager that they will be competing) at the scratch meeting. The individuals composing the team need not be determined until the team reports to the Clerk of Course.

REVIEW OF REGULATION I-12(A)

1. School "A" has only one entry in the Mansfield Relay. May this competition be counted as one of the athlete's two "Outside Competitions" instead of one of the school's 18 days of competition? ANSWER: No! The Mansfield Relay is an <u>Approved Meet</u>, therefore, participation in it must be counted as one of the <u>schools's</u> 18 days of competition

2. The local newspaper is sponsoring an Invitational Track Meet for outstanding area Track and Field contestants. The meet is scheduled the week between the Regional and Final Meets. May this meet be counted as one of the two "Outside Competitions"? ANSWER: If eligibility list and school entries are required, then this competition must be counted as one of the 18 days of competition for the school. However, if schools are not required to enter the athletes, then this may be counted as one of the two "Outside Competitions".

QUESTIONS AND ANSWERS ABOUT REGULATIONS II-SECTION 11 (A, B & C)

1. May a school schedule a "Road Race" as one of its two allowed scrimmages in either Track and Field or Cross Country? ANSWER: No! Organized competition may not be scheduled as scrimmages.

2. May the high school track coach coach during February Track Conditioning Sessions when these sessions are open to everyone in the school and community? ANSWER: No! The school's track coaches may not coach whenever there are more than three students present who are enrolled in his or her school.

3. The high school has two coaches. During February, may each coach take three different individuals to opposite ends of the gym and begin coaching their three individuals during the same session? ANSWER: No. When more than three individuals are present the Coach(s) may not coach.

4. May the high school track coach take athletes to an A.A.U. or M.I.T.C.A. Winter Track Meet? ANSWER: It would be a violation for the high school track coaches to coach when more than three students enrolled in his or her school are present even though the coach may have brought only three of these students to the competition.

5. Is it acceptable for athletes to wear their school uniform during the winter track season? ANSWER: No! The M.H.S.A.A. recommends that schools do not issue school equipment until Monday of the week in which March 1 falls.
