Southfield, Country Day claim titles

Warm weather and a light breeze provided perfect conditions Friday for the All-Oakland County Track and Field Meet at Hazel Park High. The athletes responded to the balmy conditions and top competition, setting nine Oakland County records.

Southfield won the boys competition with 79 points, edging Troy (64) and Pontiac Central (50).

Detroit Country Day had 66 points for first place in the girls competition. Rochester (60) was second and Pontiac Northern (55) third.

Southfield's Rudy Redmond set a record in the 110-meter high hurdles (13.8) and won the 300-meter low hurdles (37.5). He also joined Jason Booker, Cassidy Wright and Bobby Johnson on Southfield's first-place 800-meter relay team.

Senior Keith Wheeler of Troy dominated the sprint events, winning the 100 (10.6 seconds), 200 (21.5) and 400 meters (48.1), all in record time.

Lake Orion senior Cliff Dwelle was a dual winner, claiming firsts in the 1,600 meters with a record time of 4:15.7 and the 3,200 meters (8:18.3).

In the girls competition, Shirley and Peggy Evans led Country Day. Shirley Evans set a record in the 100 meters (12.0) and Peggy Evans won the 100-meter high hurdles (14.9). Both also were members of the first-place 800-meter (1:44.4) and 1,600-meter (4:00.5) relay teams.
